#### Sub :- Appointment to the Post of Assistant Professor of Hindi.

In response to our advertisement dated- 20/06/2013, you had applied for the post of Assistant Professor of Hindi. You were interviewed for the above post by the Selection Committee appointed by the Management under Statute No. 415 of the University of Pune.

I am pleased to inform you that the Management has appointed you on the said post in Arts & Commerce College, Yeola, Dist. - Nashik in the Scale of Rs.15600-39100+AGP 6000 with effect from 20/09/2013. Your appointment is subject to the following terms and conditions :-

1. Your services will be Governed by Maharashtra Universities Act 1994, Statutes, Code of Conduct, Ordinances and rules and regulations laid down by the University of Pune and State Government from time to time.
2. You are appointed in a clear vacancy on full-time basis on probation for a period of One year from the date of joining.
3. The post is reserved for S.T.
4. You will be paid basic pay of Rs. 15,600/- per month in the scale indicated above. You will be also entitled to Dearness Allowance, House Rent Allowance and C.L.A. at the rates prescribed by the State Government from time to time. In case you are appointed for a period of more than one year, you shall earn annual increment.
5. Your appointment and salary shall be subject to approval by the University of Pune and Director of Higher Education.
6. Your appointment is subject to the minimum number of students and the work load prescribed for the post.
7. You shall submit the originals as well as certified true copies of relevant testimonials such as birth certificate, marksheet, experience certificate, change of name certificate (if any) etc. before joining your duties.
8. In case you accept the appointment you shall have to execute Deed of contract of Service as prescribed in the statutes at the time of joining the duties.
9. You will be allowed to join the duties on producing of -
  - (a) Two passport size Photographs.
  - (b) Character Certificate from two eminent persons, one of them should be a Government Gazetted officer.
  - (c) Discharge certificate from previous employer ( if any ).

10. You shall undergo medical examination by the approved Medical Officer Dr. Shodhan Gondkar, (M.D., OB/GY), 'Ramalayam', Hospital, Panchavati Karanja, Behind Hotel Bhagwati, Panchavati, Nashik -3, within three months from the date of joining the duties.
11. You are required to give the correct mailing address as soon as you join the duties and any change in the address given earlier should be communicated to the Principal. It will be presumed that any letter sent by Registered Post Acknowledgement Due (RPAD) on the address given shall be deemed to have been acknowledged and duly signed by you.
12. You will not conduct or engage yourself in any private tuitions or private coaching classes.
13. You will not engage yourself in any other job paid full-time, part-time or other wise, during the continuance of your service, without the permission of the competent authority / Management.
14. Your services are transferable at any time, to any other Colleges run by the Management.
15. Your appointment may be terminated at any time, by either side / party by giving one month's notice or one month's pay in lieu of notice period in case the period spent in service is more than six months.
16. If you are found absent continuously for more than thirty days without permission your services will stand terminated automatically. If you are found guilty of violation of any terms and conditions mentioned above you will be liable for disciplinary action and punishment decided by the Management as provided for in the statutes. During the period of your service you shall not directly or indirectly do such things which are subversive to the interests of the Society / University / Institute / College students.
17. You have to communicate your acceptance to the Management / College / Institute within seven days from the date of receipt of the Order of Appointment failing which your appointment is liable to be cancelled.
