In response to our advertisement dated 23-06-2004 you had applied for the post of Lecturer in Political Science, you were interviewed for the above post by Selection Committee appointed by the Management under Statute No. 415 of the University of Pune.

I am pleased to inform you that the Management has appointed you on the said post in Smt. Pushpatai Hiray Arts, Science & Commerce Mahila College, Malegaon - Camp, Dist-Nashik in the scale of Rs.8000-13500 with effect from 21-08-2004. Your appointment is subject to the following terms and conditions :-

- Your services will be governed by Maharashtra Universities Act, 1994, Statutes, Code of Conduct, Ordinaces and rules and regulations laid down by the University of Pune and State Government from time to time.
- You are appointed in clear vacancy on full-time/part-time basis on probation for a period of 2. Two Year (s) from the date of joining.
  - Your appointment is purely temporary for a period of Two Years i.e. from 21-08-2004 to (b) 19-06-2006.
  - Your appointment is on the leave vacancy for the period from Nil. (c)
