

Linkage Agreement for Internship Program

This Agreement ("Agreement") is made and entered into on this 18 July 2020, by and between MGVS Arts and Commerce College, Yeola, hereinafter referred to as "the College," and Quality king Mini Mall (Mr. Shreeram Shinde), a company facilitating internships, with its principal place of business at Vinchur road Yeola, hereinafter referred to as "the Firm."

WHEREAS, the College seeks to provide valuable internship opportunities for its students, enhancing their practical knowledge and professional skills; and

WHEREAS, the Firm specializes in connecting educational institutions with companies and organizations to facilitate internship placements;

NOW, THEREFORE, the College and the Firm agree as follows:

1. Purpose:

The purpose of this Agreement is to establish a partnership between the College and the Firm to facilitate internship opportunities for the College's students.

2. Scope of Cooperation:

a. The Firm agrees to collaborate with the College to identify potential internship placements relevant to the academic disciplines offered by the College.

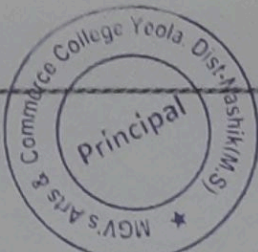
b. The College will designate a faculty member as an Internship Coordinator to liaise with the Firm and oversee the internship program's implementation.

c. The Firm will assist in arranging internships with companies and organizations based on the students' academic background, skills, and career interests.

d. The College and the Firm will work together to provide necessary orientation and guidance to students regarding the internship process, expectations, and professional conduct.

3. Responsibilities of the College:

a. The College will provide the Firm with necessary information about the academic curriculum, skillsets of students, and any specific requirements for internships.



b. The College will nominate eligible students to participate in the internship program and ensure they meet the respective criteria set by the companies or organizations.

c. The College will communicate regularly with the Firm to monitor the progress of the internship program and address any concerns or feedback from the participating students.

4. Responsibilities of the Firm:

a. The Firm will use its best efforts to identify suitable internship opportunities based on the College's requirements and student profiles.

b. The Firm will act as a liaison between the College and the participating companies or organizations to coordinate the internship placements.

c. The Firm will provide necessary information to the College about the participating companies or organizations, including their expectations and guidelines for interns.

5. Internship Period:

The internship period shall be determined jointly by the College and the participating companies or organizations. It will be communicated to the selected students in advance.

6. Obligations of Participating Companies or Organizations:

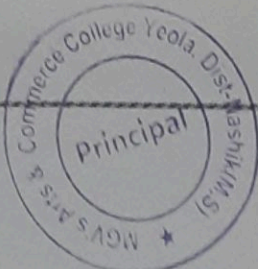
a. The participating companies or organizations agree to provide a conducive and safe working environment for the interns.

b. The companies or organizations will assign a supervisor or mentor to guide the interns and provide regular feedback on their performance.

c. The companies or organizations may offer stipends or any other form of compensation to the interns as per their policies and discretion.

7. Confidentiality and Intellectual Property:

Both parties shall ensure the confidentiality of any proprietary or sensitive information shared during the collaboration and respect each other's intellectual property rights.





8. Duration and Termination:
